I will provide Personal Lifestyle Concierge with official updated records from a licensed veterinarian and I understand that my pet may be refused boarding if I am unable to provide current vaccination records. _____

I certify that my dog(s) named above is/are presently in good health and have not had a communicable condition within the past 30 days. I further certify that my dog(s) has/have not previously harmed or shown any aggressive or threatening behavior towards any person or other dog. I understand that in making a decision to board my dog(s), the staff of Personal Lifestyle Concierge have relied on my representations that my dog(s) is/are in good health and have not previously harmed or shown any aggressive or threatening behavior towards any person or other dog at any time, for any reason.

I understand and agree that if my dog(s) is/are found to have fleas; my dog(s) will be treated with a flea bath at a fee of \$25.00 per dog. I agree to pay any charges I am assessed for the treatment of flea infestation. _____

I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are in the care of Personal Lifestyle Concierge. I further understand that Personal Lifestyle Concierge will have no liability for loss or damage caused by disease, theft, fire, death, escape, injury, harm to other persons, harm to other dogs, harm to property caused by my dog(s) while in the care of Personal Lifestyle Concierge and I hereby release Personal Lifestyle Concierge from any liability arising from my dog(s) stay with Personal Lifestyle Concierge. _____

I indemnify and hold harmless Personal Lifestyle Concierge from and against claims, damages, losses and expenses arising out of or resulting from the performance of services, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, but only to the extent caused by the negligent acts or omissions of Personal Lifestyle Concierge, or anyone directly or indirectly employed by or anyone for whose acts they may be liable. _____

I understand that there are inherent risks associated with group socialization of dogs. These risks include, but are not limited to cuts, scrapes, bites and infection. I agree that the benefits of group socialization outweigh the risks and I agree to assume these risks. _____

I understand that any medical or behavioral problems that develop will be treated by Personal Lifestyle Concierge staff at their sole discretion. I agree to assume full financial responsibility for all expenses incurred in providing or obtaining medical treatment for my dog(s). _____

I understand and agree that my dog(s) may be photographed during their stay with Personal Lifestyle Concierge. I further understand and agree that Personal Lifestyle Concierge, LLC, shall be the exclusive owner of the rights, results and proceeds from such media and may freely and without notice use any such media in advertising, promotion or furtherance of its business. _____

I understand and agree that I may be assessed additional fees if I do not pick up my dog(s) by the scheduled pick-up time. I also agree to notify Personal Lifestyle Concierge in advance if I will not be able to pick up my dog(s) by the scheduled time. I further understand and agree that if I have not picked up my dog(s) within 24 hours of the scheduled time and I have not spoken to a Personal Lifestyle Concierge staff member to make arrangements, that my dog(s) may be turned over to a local animal shelter or control center as an abandoned animal. _____
